MEMBERSHIPS

THERE ARE 2 CATEGORIES OF MEMBERSHIP:

1. PRINCIPAL MEMBER:

- 1.1 ANY PERSON WHO IS AN OWNER / OPERATOR OF A CONVEYANCING FIRM.
- 1.2 A PERSON WHO IS A LIFE MEMBER

2. MEMBER:

- 2.1 ANY PERSON WHO OBTAINS A CONVEYANCING LICENCE AND WHO IS NOT AN OWNER/OPERATOR OF A CONVEYANCING FIRM.
- 2.2 ANY PERSON EMPLOYED AS A CONVEYANCING CLERK EITHER IN A LEGAL, BANKING OR GOVERNMENT OFFICE OR CONVEYANCING FIRM WHO HOLDS THE PRESCRIBED QUALIFICATION AND HAS THE PRESCRIBED EXPERIENCE.
- 2.3 A PERSON WHO IS ASSOCIATED WITH THE CONVEYANCING PROFESSION WHO IS INVOLVED IN THE ADVANCEMENT OF THE PROFESSION
